in continuation to Finance circular No.33/2012/Fin2/14(2006) dated 17-12-2012 it is clarified that 5% rent in lieu of entitlement of rent free accommodation to the board employees residing in private accommodation through out the state is not admissible to those employees who are staying in their own houses or staying in hired houses in their own interest as per finance Circular No.11/09 dt. 26.4.09 in order to ensure proper utilization of accommodation available at the projects and to stop undue benefit of additional 5% rent.
